

This is to notify that the revised fee structure for ICTRD Accreditation Models, as approved by the Management, shall be effective from 12th December 2025. All new applications submitted on or after the effective date shall be governed by the revised fee structure.

Revised Accreditation Models & Fee Structure

1. Corporate Accreditation

The ICTRD Corporate Accreditation grants official certification and a trust seal validating organizations, their digital platforms, and products, ensuring credibility, quality, and compliance with recognized standards.

Logo Usage

- Letterheads
- Promotional materials
- Websites (with verification facility)
- Trust seal on portals and products

Fee Structure

- Application Fee: ₹5,000 + GST (Non-refundable)
- First Year Accreditation Fee: ₹7,500 + GST
- Renewal Fee: ₹5,000 + GST (Optional)

2. Primary Accreditation

Institutions are authorized to host ICTRD's globally recognized certification examinations for their students.

Logo Usage

- Letterheads
- Promotional materials
- Websites
- Signboards (Use on certificates and mark sheets is not permitted)

Fee Structure

- Application Fee: ₹1,000 + GST (Non-refundable)
- Accreditation Fee (First Year): ₹9,500 + GST
- Security Deposit: ₹25,000 (Refundable)
- Renewal Fee: ₹9,500 + GST

3. Course-Level Accreditation

Institutions may design and conduct examinations on the ICTRD platform and award co-branded certificates, inclusive of free TID Network membership for students.

Logo Usage

- Letterheads
- Promotional materials
- Websites
- Co-branded certificates

Fee Structure

- Application Fee: ₹5,000 + GST (Non-refundable)
- Accreditation Fee (First Year): ₹20,000 + GST
- Security Deposit: ₹50,000 (Refundable)
- Per Certificate (including TID): ₹100 to ₹200
(Final rate to be mutually decided on a course-wise basis)
- Renewal Fee: ₹12,000 + GST

4. Trainee Identification Number (TID) Network Membership

Organizations may join the TID Network without ICTRD Accreditation and gain authorization to assign unique, lifetime, and globally verifiable Trainee Identification Numbers (TIDs) to students.

Logo Usage: TID logo may be used as required (Use of ICTRD logo is strictly prohibited)

Fee Structure

- Application Fee: ₹3,000 + GST (Non-refundable)
- Network Membership Fee: ₹8,000 + GST (Per Year)
- TID Transaction Rate: ₹22 per entry


"Per entry" includes:

- Creation of a new TID
- Entry or updating of examination credentials
- Any additional credential-related data entry linked to the TID
